Minutes from the meeting --- January 15, 2011

The quarterly meeting of LSSCC was called to order by President Dawn Willsher at 1:25 pm, she thanked everyone for coming.

11 members were present

President asked for the minutes from the last meeting, past secretary was not present, President made a motion to accept the minutes as printed on the October newsletter, seconded by Gisela Behgooy---MC

President Dawn asked for a treasurer report----- Donna gave the report:

October 2010 beginning balance \$1418.57 with 3 deposit of \$3,395.00 and 14 withdrawals of \$3,016.07

Balance total being \$1,797.50

November 2010 beginning balance \$1,797.50 with a deposit of \$ 193.00 and 3 withdrawals for \$70.50

Balance total being \$ 1,920.00

December 2010 beginning balance \$1920.00, no deposit and 2 withdrawals of \$68.00

Ending balance of \$1,852.00

Will check PayPal account to see if anything has arrived

Motion made by Felipe Sanchez to accept seconded by Ricardo Sanchez ---MC

Old Business:

Affiliation were mention, to see if LSSCC will be affiliating with NCA for \$110.00, USTF for \$75.00 and for the American Singers n/c

Felipe Sanchez mentioned that a person was needed to contact the selected Judges for the 2011 show, he wanted to know who will be contacting them and making travel arrangements, President mentioned that the secretary will be doing it, Secretary Henry Vela asked for the list of selected Judges and address with phone numbers. President Dawn and Vice president Ricardo said they will get that information to the secretary. Gisela said that she tried for the Judges to make their own travel arrangement and LSSCC will reimburse them for the cost. Secretary asked if there was a contract to send the Judges for their assignment, Gisela said she will check, also Donna and Dawn will check and will let the secretary know if they had a contract. President Dawn said that she would send our Judges choices to Henry.

New Business:

President Dawn said that the club still had an opening for a board of director, she asked for volunteers-- no one volunteered. President Dawn said to print it in the newsletter to see if someone would come forward to fill that position.

Vice President Ricardo mention that LSSCC had a storage place and it was costing the club \$780 per year, the club needed to do something about it, also it was too far for anyone to get to the storage place it needed to be closer to the place where the show was being held. Felipe said that the rental for the storage place was \$780.00 and if we would get the tables at the show hall would be \$5.00 each which would be around \$300.00, maybe we would not need the staging stands, the club needed to do something. Felipe made a motion that a committee was needed to look for a storage place closer and maybe cheaper to the hotel where the show was being held. Maybe the committee would have something for our next meeting. Donna volunteers to check on this, she will check on a location in the Plano /Richardson area and try to have a report for our next meeting, or maybe email the board with some answers.

President Dawn said that a show manger was needed for the show for 2011, Ricardo and Felipe volunteered and also Ricardo would do the awards for the 2011 show.

Ricardo and Dawn mention that the board members needed to commit to a job for the show. Dawn said that Brenda would still be doing the catalog. Someone needs to sell ads for the catalog and sponsorships for the divisions and sections. Ricardo said we needed a person in-charge for these jobs, he asked for volunteers. Felipe volunteered to ask people for ads and also for sponsors for the divisions and sections for the catalog. Ricardo said that the cost of the catalog was about \$300.00 for 2010 show, the ads and sponsorships would pay for the cost.

President Dawn asks who would be doing the newsletter, in the past it was done by Tom Hixson, President said that it was done by the secretary. Secretary Henry said he would do it if someone would help. Ricardo said he would help.

President Dawn said that the show tags were already covered; Tom Hixson and she had enough tags for the 2011 show.

Secretary Henry asked for a membership roster, President Dawn said that the roster for membership was done by Tom Hixson, she has one and would send it to the secretary.

President said that a volunteer was needed to do the auction and raffle table for the 2011 show, no one volunteered. Secretary Henry said he would put an announcement in the newsletter to see if we could get someone to help with this job.

Donna Johnson said that a person was needed to help with the Judges at the show. She said maybe a name tag or some ID would help with who was a judge and who wasn't. Jay volunteers to do name tags for the 2011 show. This would help to see who was a judge and who was a member for all to identify at the show. Donna mention that even at the hospitality would be nice to know who was who.

President Dawn said that someone needed to check and see if enough ribbons were available to the 2011 show. Felipe said he would check. Secretary Henry said that he had a new contact and would forward the information to Felipe; maybe the price would be cheaper.

Divisions: President Dawn said that the club needed to reduce some of the divisions on the Type canaries, some of the divisions didn't have enough birds at the show to have a division, per our prior discussions and notice in the newsletter. President read what was on the last newsletter: The board voted to begin combining divisions within other divisions that are not meeting the required entrants (15) to remain as a division at the show. Discussion of combining will be held during the January meeting. If you raise a type of canary that is in jeopardy of losing its own division, you should attend the January meeting and help in the decision making process. Henry made a motion that a division cannot be eliminated and just move the birds over to any division, a call was made to second the motion, no one second the motion, the motion was not carried. President Dawn made a motion that the division 1-- Borders and division 5--- Hartz would be move to division 3---Type and would be exhibit under that division under a section with-in that division. A vote was call--- 8 for and 2 against, MC

President Dawn asked for a show Location, Ricardo said he will check on it and thinks it will still be at the same location, Henry told the president that he will ask for volunteers on the newsletter for ads and raffle items. Ricardo mentioned that there has to be donations for the ads and raffle, this is needed for our funds.

Donna volunteers to have a Garage sale to raise funds over the spring and summer months. She said she will be the DFW area for the fund raising and we needed others to volunteer for some other areas, like in the Houston and Austin areas. Donna will try in the Spring to see how it will do, we will be needing donations for the Garage sale, if anyone will have anything to donate please contact Donna Johnson.

Donna will be the person in-charge of the fund raising committee. Jay said that we should have membership forms at some of the bird marts and bird shows, maybe this will increase our membership. Ricardo told Donna to send emails to members to see if we could get some donations for the fundraising.

Luis Rodriguez said we should have a liaison person for new members and visitors so they will know what is going on at our show. Tricia said we should have more information on birds and who to contact in case someone will need a bird. Donna said maybe we should have a welcoming committee at our show, for everyone that comes to the show. Kathy volunteered to be the welcoming person to our show.

President asked for a location for our next meeting, Gisela Behgooy volunteered to have our next meeting at her place, it would be in April, the 3rd Saturday.

President adjourns the meeting, second by Jay Burzlaff at 4pm.

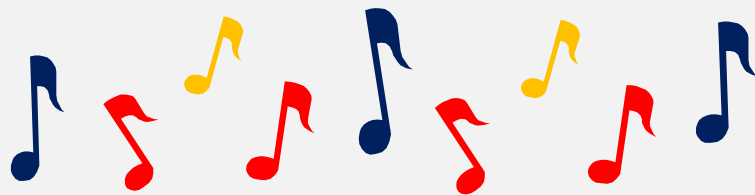
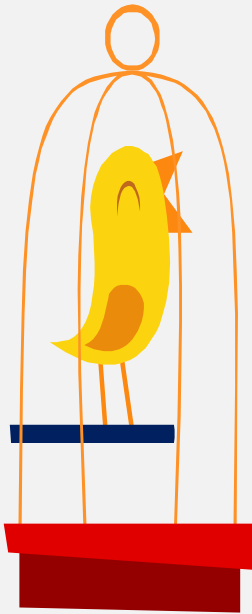
